Amendment No. 002 is hereby issued to modify Solicitation No. EW525-140541/A and respond to questions raised during the solicitation period.

Q1. Must the prime consultant be an architect firm? Or could it be an engineering firm?

A1. The prime consultant can be either.

Q2. Mandatory requirement 3.1.2 : Is it mandatory to include an architect firm in the project team? The above question pertains to the fact that our team includes very strong physical security experts and structural engineers that have accomplished many similar projects.

A2. There is an arch component that needs to be satisfied. Need a architect sub consultant at the very least.

Q3. Rated requirements 3.2.2 : do we have to fill this section only if we are using sub-consultants? If not, what is the difference between this section and section 3.2.1 ?

A3. Yes, bidders are expected to provide the information required in 3.2.1 and 3.2.2 as we expect to fill the requirement sub-consultants will be required. Because of the requirement, no comparison is required.

Q4. Mandatory requirement 3.1.1 : it is required that the proponent must be licensed in the province of Manitoba, however the scope of work is to be performed in Saskatchewan. Please clarify.

A4. This is a typo, should read "Saskatchewan."

Q5. What is the services and expertise required for the architect?

A5. Design and drawing of sally port gates etc.

Q6. Term of reference document Section 1.8.1, page 7 of 16 : Will the architect firm that produced the assessment report be allowed to bid either as prime or as sub consultant?

A6. Yes, they will be able to bid as either prime or sub.
