Solicitation Amendment No. 002a is raised to answer questions from a bidder:

## August 8, 2013

## Question:

"...Under Item no C. 8 - Rear Rack Capacity - 150 lb. (not convertable seat) - minimum, does this mean you do not want the box option with the convertable 2-up seat? Or can it be a 2-up convertable seat as long as it meets the rear rack capacity spec? Also would the RCMP accept a unit that has a front rack as well as a front box below it?..."

## Answer:

The ATV's MUST have a 2-Up seat and MUST have a rear rack with a 150 lb. capacity; at the same time, not in place of, as there is a need for two people to be able to sit on the machine and carry gear or equipment in the front and rear racks.

The upper front rack is mandatory. The additional box below would not be factored into the evaluation; as it is not a requirement in our specifications. However, it would still be allowable as long as it does not reduce or diminish the operation of the machine. The additional box below cannot replace either rack. Both front and rear racks are required.
