QUESTIONS AND ANSWERS

Question #006:

R1: Please confirm that the response does not require submission of actual reports or sections of reports from previous PIAs. This content is sensitive and cannot be shared without approval from the owner of the PIA. Only a description of the PIA process can be provided which will confirm that each of the 4 rated elements was included in each PIA. Is this acceptable?

Answer #006:

Yes.

Question #007:

R2: A PIA does not normally take 3 months. In order to meet this requirement, is it required that the resource performed other activities on the project besides the PIA?

Answer #007:

There is no "normal" completion time for Privacy Impact Assessments (PIA). Under evaluation criteria R2, we will accept projects for which the proposed candidate worked on for at least three (3) months within the last ten (10) years and on which the candidate completed a PIA (as described in R2).
