CLARIFICATION QUESTIONS:

Note: clarification questions are numerically sequenced upon arrival at PWGSC. A question and its answer will be provided via the Government of Canada's tendering web site BuyandSell.gc.ca as responses become available. Potential Bidders are therefore advised that questions and answers may be issued via BuyandSell.gc.ca out of sequence.

The following clarification questions were received from a potential Bidders. In accordance with Article 13 under 2003 (2013-06-01) Standard Instructions - Goods or Services - Competitive Requirements, which has been incorporated into the RFP, and in accordance with Article 2.1 c) of the RFP, the clarification questions and corresponding answers are provided to all potential bidders as set out below:

Question 2:

Are the requested services for the above-referenced solicitation currently being provided or have they been provided previously? If so, please identify the means by which such services have been supplied (e.g. direct and/or term employee(s), personal services contract(s), or contracted services through a company). If the services were contracted through one or more companies or individuals, please provide the name(s) of the contractor(s), the duration and dollar amount of the contract(s).

Answer 2:

The requested services for the HRMS Technical Upgrade from 7.5 to 9.1 are not currently being provided and have not been provided previously.

Question 3:

Can we bid a single resource in more than one category and/or stream?

Answer 3:

In accordance with article 3.1 iv of Part 3 (Bid Preparations Instructions) of the RFP, "The same individual must not be proposed for more than one Resource Category or more than one Workstream." As such, bidders cannot propose the same resource in more than one category and/or Workstream in response to the RFP.

Question 4:

For the ERP Programmer Analyst role, Workstream 2, the anticipated Level of Effort (i.e. number of days) drops significantly in the option periods. Does DND intend to use fewer resources or use resources on a part-time basis?

Answer 4:

The Estimated Level of Effort in Attachment 4.2 of the solicitation is based on an estimate of 20 day per month calculation that reflects the duration of each proposed contract period. DND has a requirement for up to 4 ERP Programmer Analysts for each valid contract period.

Question 5:

Given the extensive level of effort in meeting the additional mandatory and rated requirements as identified on page 1 of 41 in Attachment 4.1 we kindly request a 2-week extension to the due date.

Answer 5:

Please see Question and Answer No. 1) and associated RFP Change No. 1) set out under Solicitation Amendment No 001 published on August 12, 2013. Please note that the bid closing date has been extended to September 5, 2013.
