Question 1) Is this all or nothing, or will partial awards be considered?

Answer to Question 1: One standing Offer will be issued for this requirement. No partial awards will be issued.

Question 2) Can you please clarify the specifications for items 1 through 4 as the height , width capacity measurements seem to be incorrect. (ie. Double container dimensions (item2) are the same as quadruple container dimensions (Item 4) but capacity is greater)

Item 1: sizes accurate

Item 2: Sizes accurate

Item 3: Dimensions: 47.5"L x 25" w x 44.5" H Capacity 90 gallons Item 4: Same dimensions as Item 3

Question 3) Are items 5,6,and 7 "roll out carts"? (do they need to have 2 wheels and an attached lid?)

Answer to Question 3: Yes they are roll out carts. They require 2 wheels. Lid information is described in Annex A- Requirements of the Request for a Sanding Offer (RFSO) documentation.

Question 4) Is item 8 an open topped container or should it have some sort of lid and or restricted openings?

Answer to Question 4: Lid information is described in Annex A- Requirements of the Request for a Sanding Offer (RFSO) documentation

Question 5) Item 9 does this need to have an attached lid?

Answer to Question 5: Lid information is described in Annex A- Requirements of the Request for a Sanding Offer (RFSO) documentation

Question 6) Items 10 and 11 are identical except for a small variance in height is this correct or is a single height model acceptable for both?

Answer to Question 6: Yes, Items 10 and 11 are identical except for small variance in height as described in Annex-B- Basis of Payment

Question 7) Is there a colour preference for the salt boxes? (Yellow?)

Answer to Question 7: Yellow are blue are acceptable.

Question 8) Item 15,16,17,18,19. How many compartments is each of these stations?

Answer to Question 8: One compartment for each

Question 9) Item 20, 21, 22, 23. Is this a side deposit unit or a top deposit unit? (Where is the trash deposited into the container?)

Answer to Question 9: Top deposit on slanted part

Question 10) Item 20,21,22,23. How many compartments is each of these stations?

Answer to Question 10: One compartment for each.

Question 11) Are there images/drawings available for all line items as a starting reference point for suitability and cost?

Answer to Question 11: No, there are no images/drawings available for all line items.

Question 12) As shipping costs vary widely based on amount shipped, what will be considered the minimum order quantity for each item?

Answer to Question 12: Estimated quantities per line item for waste containers are listed in Annex B- Basis of Payment in the RFSO document. There is no known minimum order quantity because the quantity of goods, level of services and estimated expenditure specified in the RFSO are only an approximation of requirements given in good faith.
