The following clarification question was received from a potential RFI Respondent. In accordance with Article A.12 of the LOI, the clarification question and corresponding answer are provided to all potential Respondents as set out below:

**Questions 2a) and 2b)**

Could you clarify the following items in the subject RFI:

- a) Item A.3.B Nature of Responses Requested: This item states that respondents should provide answers to Appendix A along with any general comments on any of the documents. Our understanding is that we should provide answers to both Appendix A and

B, as well as any general comments. Can you confirm that our understanding is correct.

- b) The numbering the Commercial Questions in Appendix A appears to have been duplicated for item 2.3 (page 12) i.e. both "Off-Ramps" and "Fee Structure" have the same number. Should we replicate this numbering in our response?

**Answer 2a)**

Your understanding is correct. Respondents are requested to provide Answers to the questions set out under Appendix A (Questions to Industry) and Appendix B (Key Mandatory & Point Rated Evaluation Requirements) and to provide any other general comments or feedback requested under the RFI.

**Answer 2b**

You are correct, there is a typing error which has resulted in the duplication of the numbering in this case. To void having to revise the numbering sequence for Commercial Questions "2.3 Off-Ramps", "2.3 Fee Structure" and the applicable subsequent Commercial Questions, when responding to the LOI (English or French version), Respondents are requested to replicate the current Commercial Questions numbering currently set out in the LOI.
