This Amendment is raised to provide clarification to a response provided in amendment 005.

Question 1 from amendment 005:

1) Annex B - Basis of Payment; 3.0 - Westbound (3.1.4/3.2.4)

These sections state that terminal handling charges will be as per actual invoices paid to a third party. Are these terminal charges paid in Canada to the port or steamship line? Please define and confirm that this only applies on Westbound shipments. (pages 88 and 90)

Answer 1 from amendment 005:

Terminal handling charges may occur anywhere in the shipment process (east or west). Where ever they occur the actual will be paid.

Clarification:

Can you confirm that terminal handling charges are separate (not included in) from the rates we are quoting? In other words THC is not included in the rates, and that the contractor will submit the actual invoices, to the Government, paid for Terminal Handling Charges to 3rd parties. Canada will reimburse the Contractor the cost paid for all THC plus the admin fee (clause 12.5 on page 103).

Clarification Response:

Terminal handling charges are third party and not included in the bid rates. Admin fee applies.
