## Answers

### Dimension and tolerance:

The drawings supplied with the specification are not manufacturing drawing. The manufacturer has to produce their own drawing and qualify each part and assembly to make sure it meets the requirement described in the specification. The overall dimension must be as per drawing A-1 & B1 for each specification (CCMS 108, 125 and 130).

### Anti-tip/interlock mechanism and counter weight:

It's up to the manufacturer to come-up with a solution that perform and function as describe in the specification (safety system and tip over).

### Drawer slides

If the slide in the specification can no longer be supplied, an equivalent will be acceptable.

### The slide must be:

- Heavy duty with a load capacity of minimum 150 lbs.
- Have a latch device
- Design for metal cabinet
- Mountable with mounting tabs.
- Drawer must have the capacity of being fastened with the tab.
- Extend to use the full drawer capacity
