There will be a suspension of work on site from mid January 2014 to late June 2014. The contractor will then re-mobilize from late June 2014 and work on site until end of August 2014 and the balance of the work is to be completed by January 2015.

The entire period of the contract shall be completed within sixty-three (63) weeks from the date of acceptance of the offer.
