1- Question:

For emergencies to respond in a time of 8 hours, is it at any time (24 hours a day 7 days a week)?
What are your operational hours?

1-Answer:

Availability on weekdays and during business hours only (0700 to 1600, from Monday to Friday).

2- Question:

For work on site, what types of work are there? Do we have to use your equipment (tools) on site or do we need to provide? E.g.: Welding machine.

2-Answer:

Very little work on site will be necessary, they are essentially made to take measurements on the pieces that will be manufactured.

3- Question:

Is there any safety training to undergo to access worksites? E.g.: Integration.

3-Answer:

Safety/Welcome briefing including information on the rules and regulations in the workshop will be given.

4- Question:

Is there any individual protection equipment other than protective toe boots and safety glasses required to work on your sites? E.g.: bib, working clothes with reflective bar...

4-Answer:

Standard PPE is required, this minimally includes: hearing protection (if required), protective toe boots and safety goggles.
