Amendment #001**BIDDER'S QUESTIONS:**

Q1. Can you clarify for me what "brand" actually means so I can quote accordingly. Where a brand is specified is that a preferred brand name and another brand name is acceptable or does it mean that brand and that brand only ? I ask because I have experienced the interpretation both ways in the past, where a brand was preferred but another brand name was acceptable and only the brand name specified was a must if the tender read "Brand ABC ONLY".

A1. All items that identify a brand name are 'no substitute'.

Q2. item #160 of the tender—Pizza Crust. The item description says "pizza crust, plain, frozen, pack size 14x510 g. with no "brand" identified. The price of pizza crust varies dramatically by type of pizza—sheeted/round, par baked/non par baked as well as by supplier.

A2. Items #148, 149 and 160 have all been revised to state "Rich's" which is a no substitute product.
