Questions and Answers Set No. 4

Question No. 1: For Corporate criterion R2, can the crown provide its definition of an “inter-jurisdictional project” and if provincial/municipal projects meeting the crown’s definition of “inter-jurisdictional” would qualify?

Response No. 1: The Crown defines Inter-Jurisdictional project as projects involving at least two levels of government such as federal/provincial/municipal.

Question No. 2: For Corporate criterion R3, would the crown consider the Canada Revenue Agency (CRA) and HRSDC as clients with a social security setting?

Response No. 2: Yes.

Question No. 3: For Corporate criterion R3, would the crown consider public safety clientele that can not provide client contact information due to the sensitivity of their organization?

Response No. 3: No. The Crown cannot consider any responses that cannot be validated.

Question No. 4: Due to the significant change made to the RFP mentioned on Amendment No.3 Question No.1 which was sent out one week before bid close we respectfully request an extension in order to re grid new candidates.
