QUESTION 1

Both the Northern Store (204-565-2019) and the Nursing Station (204-565-2370) located in Shamattawa have indicated that they do not have space available to accommodate contractors that the RCMP will be hiring to come into the community to complete the repairs. Do you have a plan to assist the potential bidders with accommodations while we are there?
