Question: 1

Water Softener:

- Twin tank softeners 48'000 grain capacity per tank or total for both ?
- Twin high flow is 15 gpm minimum flow with both 48,000 tanks online
7.5 gpm minimum flow when one tank is regenerating.

Answer: 1

48'000 total for both.

Question: 2

- Can the control valve be constructed of "NORYL fibreglass reinforced composite?

Brass is rarely used in the industry any more for this size of unit. We have used the "Pentair Autotrol" valve for over 25yrs. It is very reliable and well constructed. Pressure tested to 300psi in the factory. It uses a camshaft to activate flapper valves. No o-rings to be damaged by abrasives.

Answer: 2

Question: 3

Ultra Violet Sterilizer:

- Certification Standard NSF55B is an older standard and has been replaced by NSF55A

We can not supply a 55B unit to supply 15 gpm

55B specs 40mj/cm2 lamp intensity and can be achieved by non NSF certified units

- NSF55A includes a light intensity monitor and optional solenoid shutdown of water supply.

- Can we supply a non certified unit that achieves 55B specs?

Answer: 3

No, supply to the latest standard.
