Amendment 002

This amendment is rasied to answer questions.

Q1: If you would like to look deeper than the current line lengths allow, how much longer are we able to make the survey lines?

A1: The survey lines shown in the SoW are generalized and open for discussion with the bidders: depending on time, weather and ground conditions the survey lines could be extended by 50-100 m for all orientations (note the constraining factor of the railway track right-of-way will present some issues for the surveys).

Q2: For the Electro-Magnetic Survey, are you asking for an EM31 survey or an EM34?

A2: EM31 survey would be sufficient but bidders may offer EM34 survey to allow greater depth penetration as long as bidder stays within the specified budget.
