Q1) Ref Page 18 Of 61

- a. Code of Conduct and Certification – Bid of Standing Instructions 2003.
- b. Please provide copy or provide web access address

Please note that there is an amendment stated on page 6 of 61:

*Section 01 – Code of Conduct and Certification – Bid of 2003 referenced above is amended as follows:*

*Delete subsection 1.4 and 1.5 in their entirety.*

Q2) Ref. Page 22 of 61

- a) Is bidder required to submit application for security clearance before submitting bid or with bid document? Or will this application only be required from successful bidder?

A2) Only the successful bidder will be required to submit security clearance application after the conditional bid award.



Q3) Ref Page 31 of 61

- a) Para 1 refers to Skill Assessment. This was not attached as stated. Please supply.

A3) The RCMP Skills Assessment is found on page 21 of the course standard "Inland Water Transport Course - Basic" (CL5001). The course standard was uploaded with Amendment 001. The Inland Basic Water Transport Course Training Standard file is called: "Amend 001 Attachment001 - inland\_water\_trans\_basic\_2004\_e.pdf".

Q4) Ref Page 33 of 61

- a) Please supply RCMP Mission Core Value Statement.

Q5) Ref Page 36 of 61

- a) Para. 3. Is the contractors training material to be shipped to individual members six weeks prior to the course and will the members personal information be supplied. Alternatively, to what address will the material be shipped.
- b) Will this required material to be shipped to the PRTC in blocks of 8 students or to multiple destination.

A5a) Each candidate's detachment address will be supplied to the Contractor to mail out material - there is no alternative address.

Q6) The Basic Water Transport Training Standard (CL5001) as supplied in response to our last request does not have an annex G referred to in the solicitation. Please confirm the substance of annex G is part of the text supplied or supply annex G.

A6) The Basic Water Transport Training Standard (CL5001) is known as the "Inland Water Transport Course – Basic " (CL5001). In the Solicitation Amendment 001 of the RFP, there have been attachments uploaded for bidders to view. The Inland Basic Water Transport Course Training Standard file is called: "Amend 001

Q7) Ref. Page 41 of 61. Item VI Please identify locations of E Division small vessel fleet.
