Question

Under the safety clause in this bid you are asking for a NSM. This NSM is only applicable to Canadian made trailers. All imported trailer carry a clause on the serial plate that states:

"Trailer meets or exceeds all Canadian standards at time of build"

This is the import certification required by Transport Canada for border clearance.

Response

The Safety requirements have been amended to reflect the NSM concerns.

Safety: The trailer shall conform to all relevant Canadian Motor Vehicle Safety Standard Regulations and all applicable laws governing trailer use on roadways at the time of manufacture. The trailer shall carry the National Safety Mark when produced in Canada.

All other terms and conditions remain unchanged.

**PURCHASE DESCRIPTION
FOR
TRAILER, ENCLOSED, V-NOSE, SNOWMOBILE**

Description: The following describes requirements for a commercial grade V-nosed enclosed snowmobile trailer.

Instructions - The following instructions **shall** be applied to this Purchase Description:

- (a) Requirements, which are identified by the word "**shall**", are mandatory. Deviations will not be permitted;
- (b) In this document "provided" **shall** mean, "provided and installed";
- (c) Where certification is required, the Contractor **shall** provide the certification or acceptable proof of compliance, upon request;
- (d) Metric measurements **shall** be used as defining the requirement; and
- (e) Dimensions stated as nominal **shall** be treated as approximate dimensions. Nominal dimensions reflect a method by which materials or products are generally identified for sale commercially, but which differ from the actual dimensions.

Definitions:


"Technical Authority" is the government official responsible for technical management of this requirement. The Technical Authority is the Director Support Vehicles Program Management.

Safety: The trailer **shall** conform to all relevant Canadian Motor Vehicle Safety Standard Regulations and all applicable laws governing trailer use on roadways at the time of manufacture. The trailer **shall** carry the National Safety Mark when produced in Canada.

Trailer Dimensions:

Trailer Length: The internal box length of the trailer *shall* be at least 6,600mm. The trailer *shall* have a V-nose in addition to the trailer box length with a nominal length of 1,500mm. The total enclosed length of trailer will be approximately 8,100mm.

Trailer Width: The trailer *shall* have a nominal internal width of 2,100mm.

Trailer Height: The trailer *shall* have a nominal internal height of 1,800mm.

Trailer Capacity: The trailer *shall* have a carrying capacity of at least 2,200kg. The capacity stated is in addition to the weight of the trailer.

General Requirements:

Trailer Doors:

Rear Ramp: The trailer *shall* be equipped with a full width rear ramp.

Front Ramp: The trailer *shall* be equipped with a curb side ramp located on the V-nose of the trailer box.

Side Door: The trailer *shall* be equipped with a side man door.

Trailer Locks: All trailer doors *shall* be equipped with padlock hasps to secure each door.

Tongue Support: The trailer tongue *shall* be equipped with a support for the tongue capable of supporting a fully loaded trailer while the trailer is not in use. The tongue support *shall* be capable of being stowed when trailer is in use.

Hitch: The trailer *shall* be equipped with a hitch suitable to attach to a 2 inch or a 2 5/16 inch trailer ball.

Snow Mobile Tie Downs: The trailer *shall* be equipped with provisions and necessary equipment to securely tie down and transport 4 snowmobiles simultaneously. Any hardware required to securely tie down 4 snowmobiles *shall* be provided.

Wheels: The trailer *shall* be equipped with rims and tires suited for all season road use. Wheels *shall* have a capacity exceeding the load of a fully loaded trailer.

Spare Tire: The trailer *shall* be equipped with a spare tire. The spare tire *shall* be equipped with the same rim and tire as the wheels installed on the trailer. The trailer *shall* be equipped with a mounting location for the spare tire.

Brakes: The trailer *shall* be equipped the manufacturer's standard electric brake system.

Electrical: The trailer *shall* be equipped with the manufacturer's standard electrical systems including a 7 pin connector.

Lighting: The trailer *shall* be equipped with lights and reflectors in accordance with CMVSS. The trailer *shall* be equipped with at least one (1) interior dome light.

Roof Vent: The trailer *shall* be equipped with at least one (1) roof vent.

Colour: The trailer *shall* be black in colour.

Required Documentation:

Manual: Two (2) copies of the trailer manual *shall* be provided. One (1) copy *shall* be delivered with the trailer. The second copy *shall* be delivered to the Technical Authority. The manual *shall* include information such as identifying any potential hazards during operation, proper wheel nut torque specifications etc.

Warranty Letter: Two (2) copies of the warranty letter *shall* be provided. One (1) copy *shall* be delivered with the trailer. The second copy of the warranty letter *shall* be delivered to the Technical Authority.

Data Summary: A bilingual Data Summary *shall* be provided. The Data Summary *shall* be completed on the Technical Authority's template with data and a vehicle picture. The Contractor *shall* provide a Data Summary prior to shipment of the trailer.

Photographs: Two (2) digital pictures *shall* be provided to the Technical Authority. The pictures *shall* include one left-front three-quarter view, and one right-rear three-quarter view. The pictures *shall* have an uncluttered background. The pictures *shall* have a size of at least four (4) Mega pixels.
