## **QUESTION**

### 1. Regarding Addendum No. 2 - SCO1 - INSURANCE TERMS

In terms of the Fixed Site requirement, I would like to note that a CPL policy normally covers the transit exposure. If you are still looking to have fixed site coverage, would it be for the work site or the 3<sup>rd</sup> party disposal site (or both)? Insurer would need Phase I and II to consider.

## **ANSWER**

Delete Answers to Questions 1 and 2 in Addendum No. 2.

Type 1 - Fixed Site Coverage and Type 4 Contractors Professional Liability coverage is being taken out of the Insurance Terms. See No. 2 below.

Delete in its entirety and replace with:

IT3 G2040C Environmental Impairment Liability Insurance (2008-05-12)

#### 1. The Contractor must obtain:

Type 2: Contractors Pollution Liability" insurance, and maintain it in force throughout the duration of the Contract, in an amount usual for a contract of this nature, but for not less than \$1,000,000 per accident or occurrence and in the annual aggregate.

2. If the policy is written on a claims-made basis, coverage must be in place for a period of at least 12 months after the completion or termination of the Contract.

3. The policy  
Type 2: Contractors Pollution Liability"  
must include the following:

a. Additional Insured: Canada is added as an additional insured, but only with respect to liability arising out of the Contractor's performance of the Contract. The interest of Canada as additional insured should read as follows: Canada, represented by Public Works and Government Services Canada.

b. Notice of Cancellation: The Insurer will endeavour to provide the Contracting Authority thirty (30) days written notice of policy cancellation.

c. Separation of Insureds: The policy must apply to each Insured in the same manner and to the same extent as if a separate policy had been issued to each.

d. Contractual Liability: The policy must, on a blanket basis or by specific reference to the Contract, extend to assumed liabilities with respect to contractual provisions

e) Asbestos Abatement: To provide coverage for the removal and disposal of asbestos material

Add:

IT4 - G2020C Automobile Liability Insurance (2008-05-12)

1. The Contractor must obtain Automobile Liability Insurance, and maintain it in force throughout the duration of the Contract, in an amount usual for a contract of this nature, but for not less than \$2,000,000 per accident or occurrence.
