Q. Part 1, Section 2.: Could you please provide the exact (sub) section of the Canada Shipping act outlining the VDR regulations including the revision date.

A. For the Canada Shipping Act, you can mainly refer to these parts :

Regulations

35. (1) The Governor in Council may, on the recommendation of the Minister of Transport, make regulations

(d) implementing, in whole or in part, an international convention, protocol or resolution that is listed in Schedule 1, as amended from time to time, including regulations

Regulations

120. (1) The Governor in Council may, on the recommendation of the Minister, make regulations respecting the safety of vessels or classes of vessels and of persons on board or loading or unloading a vessel, including regulations

(b) specifying the machinery, equipment and supplies that are required or prohibited on board vessels or classes of vessels;

For the regulation, they can have direct access to the regulation : Voyage Data Recorder Regulations, SOR/2011-203

The Act is also specified within the regulation (beginning) : His Excellency the Governor General in Council, on the recommendation of the Minister of Transport, pursuant to paragraph 35(1)(d) of the Canada Shipping Act, 2001Footnote a, hereby makes the annexed Voyage Data Recorder Regulations.

Therefore, they consider that 35(1)(d) is more important, because the Canada signed the agreement for the International Convention on VDR...
