Part A: Questions and Answers

Q1. On page 21 it mentions an Annex C with drawings. I have been unable to find any drawings, even after going through the technical specification files. Can you please direct me to the drawings?

A1. The drawings for this solicitation did not upload correctly. They will be loaded as separate attachments with this solicitation amendment.

Q2. On page 17 of the RFP – Annex B – it states that “bidders must submit firm all inclusive prices”. Does this mean you would like delivery and installation pricing included in each item, rather than as a separate line item?

A2. Page 17 of Annex B - Basis of Payment, will be amended to reflect the Pricing schedules and will request for unit prices.
