Question 7:

The requirement in this section appears to be contrary to the Policy on Green Procurement which is linked to p.6 of the solicitation.

In essence, this section requires that each device is collected and transported from the CSC site to the vendor after each and every use, then returned in the same manner; the purpose of that transportation being to inspect, clean and test. Two of these activities will already have been conducted by CSC at the point of removal, in that they will know whether the device was working from their monitoring and they will visually inspect it to identify whether that subject has damaged it. The only remaining element is cleaning, which involves a quick wipe taking but a matter of seconds.

The Policy on Green Procurement seeks to reduce the environmental impact of Government operations and promote Environmental Stewardship; this procurement appears to conflict with that.

Moreover, the impact on the staff of the CSC will be to add to the time that it takes them to undertake the process (e.g. packaging, and informing the vendor) as well as the additional cost of the activity which will ultimately increase the daily rate.

In situations where no maintenance or repair is required, would the CSC consider removing this element from the procurement for the reasons stated above?

Answer 7:

In regard to cleaning the EM devices once theyve been removed from offenders, this would not be possible since CSC staff are not responsible for cleaning equipment. Once an EM device has been removed from an offender, CSC expects that it will be sanitized by the vendor prior to being sent back to CSC for use on another offender.
