## Questions and Answers

---

1. **Question:** What is the previous award information (vendor and price, or previous MERX solicitation number)?

**Answer:** There is no previous award information. Solicitation 1000312683 (Clothing – Vests and Caps) closed on July 5, 2013 but did not result in a contract award.

2. **Question:** Will all the items be awarded to the same vendor, or is the CRA open to splitting award between vests and caps?

**Answer:** Yes, all items will be awarded to the same vendor. CRA will not be splitting award between vests and caps

3. **Question:** Must the items be manufactured in Canada?

**Answer:** The items do not have to be manufactured in Canada.

4. **Question:** Must pricing be provided in a separate envelope from the rest of the proposal?

**Answer:** In accordance with Part 3, Proposal Preparation Instructions, on page 12 of the RFP:

CRA requests that bidders provide their bid in separately bound sections as follows:  
Section I – Technical Proposal  
Section II – Financial Proposal  
Section III - Certifications

5. **Question:** What was the total dollar value for the past contract? Who was the vendor for the past contract?

**Answer:** There is no past contract.

6. **Question:** Are you able to provide me with the approximate quantities per item for the past contract?

**Answer:** There is no past contract.

7. **Question:** Do the Vests and Caps need “made in Canada”?

**Answer:** The vests and caps do not need to be made in Canada.

8. **Question:** At 7.3 DELIVERY DATE at Page 21, Delivery Required – Firm Quantity; “All firm deliverables must be delivered to the locations outlined in Section 5.0 of Annex A, Statement of Work, within 30 days from CRA approval of final Pre-Production samples.”

Could it be possible to extend the delivery date to within 90 days because our production & shipping for this tender will need around 90 days?

**Answer:** No, the delivery date will not be changed to within 90 days. The RFP has been amended to change the delivery date to within 60 days. Please see amendment below.

2) In Annex A, Statement of Work, at Section 5.1.4 DELIVERY;

**DELETE:**

All vests must be delivered to the locations identified on schedule below within 30 days from approval of final Pre-Production samples.

**INSERT:**

All vests must be delivered to the locations identified on schedule below within 60 days from approval of final Pre-Production samples.

3) In Annex A, Statement of Work, at Section 5.2.3 DELIVERY;

**DELETE:**

All caps must be delivered to the locations identified on schedule below within 30 days from approval of final Pre-Production samples.

**INSERT:**

All caps must be delivered to the locations identified on schedule below within 60 days from approval of final Pre-Production samples.
