3. QUESTIONS AND ANSWERS

Question 2

RE: Shipping/Fuel Surcharges

After thorough review of the Financial Proposal grid most particularly Table J and as well as Annex B section B2 Price escalation, there seems to be no indication of fuel surcharges and its impact on the shipping charges. SJC feels that there is concrete validity to today's fluctuating fuel surcharges and its impact that this could have on the shipping rates on a monthly basis, this in return could create substantial losses to the selected contractor.

Would CRA consider a formula to be included in Annex B: Basis of Payment similar to the one used for B.2 Price Escalation/De-escalation, in regards to fuel surcharges?

Answer 2

CRA has carefully considered your concerns with regards to the fuel surcharges and we have determined that we would not consider making any changes to the Financial Proposal or the Basis of Payment with regards to fuel surcharges.

Question 3

Given the amount of information and detail required to properly respond to this RFP, we do not feel it is possible to adequately respond to this opportunity without some additional time being granted. **Therefore, given the size and complexity of this bid, may we respectfully request that the due date be extended by one month?**
