1) Question:

We do not publish catalogues or printed material with our pricing. All of our pricing is on-line. Would a "computer printout" of the bid items showing our current prices be acceptable?

Answer:

Answer:

The list price is the catalogue price. The Unit Price column is the final price adjusted for discount or mark-up.
