Amendment 002

This amendment is being raised in order to provide the answers to questions submitted by bidders

1) Drawing E9 (notes 21+22) This calls for relocation pipes for the heating system. Please verify the pipe sizes and if they are insulated.

Please refer to attached photo #8273 which shows 2 vertical and 3 horizontal un-insulated 1" and 1-1/4" pipes to the floor drain, which may need relocation. Pipes should be relocated so as not to interfere with the new cables, while still discharging into the same floor drain.

2) Could you provide as many pictures as possible of the existing installations and also showing breakers and connections at the main Switchboard S1 and S2?

Please see attached photos for information only. Contract documents take precedence.

#6958, typical feeder connections at distribution panels S1 and S2

#7039, Panels NPPA and EPPA, building A and transformers to be raised

#7118, Panels EPPS and NPPS, building S and transformers to be raised

#3376 Deteriorated conduits in crawlspace under stairway, between buildings MHU and MHK

#3336 Deteriorated conduits to be replaced, east end of crawlspace K.

3) Site office and sanitary facilities as per 012111.10 and 1.12 is this required? If yes, can this be placed on site close to the working area?

Institution can provide meeting space for regular site meetings. Contractor is to provide temporary lockable storage space in basement area. Institution washroom facilities may be used by workers for work in the basement. There cannot be movement in and out for breaks, lunch etc. Once workers are in the basement area, they are to remain there for the duration of their work day. No consideration will be given for delay claims due to inmate movement periods. Office space is to be provided by the contractor. Temporary office trailer may be located adjacent to the main electrical room. During work in the Main Electrical Room, provide temporary sanitary facilities (portapottie) adjacent to the Main electrical room."

4) It is noted that we are to provide new breakers in S1 and S2 panels. Please verify that it is the intent to shut down both panels in a night outage at different times to change the breakers. If this is the intent then 6 panels will be down at each outage. Please confirm that these meet approval.

Please refer to specification section 01 11 00 1.6.3.3: Breakers in distribution panels S1 and S2 are to be replaced overnight between 11 p.m. and 6 a.m. Safe working practices may require that distribution panel 'S1' or 'S2' to be completely de-energized for feeder breaker replacement, per OESC section 2-304 (1). Power outages are to be coordinated with the Chief of Plant Maintenance. A number of power outages will be likely be required over several nights to replace all the breakers in order to reduce the duration of each outage.
