AMENDMENT # 2

General Questions:

Item #1:

Q: One of the spreadsheets list 26 bldgs. for Gander area but the other lists 23, which one is correct? Exactly how many bldgs. are in the Gander area?

A: On one list there is three buildings that has no reporting devices or sprinkler they are storage buildings they are Building 20 Building 111 and building 113.

Item #2:

Q: On one spread sheet there are kitchen systems in Corner Brook and GFW, but on the other spread sheet it only shows for Gander.

A: It should read as Kitchens in GFW, Corner Brook and Gander, the spreadsheet may have some data not showing from one to another we apologize for this mistake.

Item #3:

Q: Does the \$1,500 have to include all systems, or is it per system. For example, \$1,500 for fire alarm, \$1,500 for sprinkler, etc.

A: Yes, the \$1,500 is to include all systems.

Item #4:

Q: With regards to Section 8 General Requirements, I need clarification on 8.5, 8.5.1, 8.6 and 8.6.1. Does it mean that we have to replace anything under \$1,500 only at the time of inspection or at any time during the year that a service call comes in? If it is for service calls too, does it mean that whenever a service call comes in, we have to include anything under \$1,500 in our overall contract price. Also, is this \$1,500 per bldg. or total for all bldgs?

A: The \$1,500 is for each scheduled maintenance to be performed during the Monthly, Quarterly, Semi annual, and annual inspection and the work will be done at the time of the inspection.

So for twelve months you will have 12 times \$1,500 which come up to a total of \$18,000 for the year which is part of each inspection.

Note: This is a service contract and the only other call ups that will be raised would be anything above the \$1,500 threshold
