The Department of Agriculture and Agri-Food Canada (AAFC) has a requirement to put in place a contract with the Ontario Federation of Agriculture (OFA) to carry out data collection and analysis activities on the corn fields of its members.

The purpose of this Advance Contract Award Notice (ACAN) is to signal the government's intention to award a contract for these services to the pre-selected supplier:

Before awarding the contract, however, the government would like to provide other suppliers with the opportunity to demonstrate that they are capable of satisfying the requirements set out in this Notice, by submitting a statement of capabilities during the 15 calendar day posting period.

If other potential suppliers submit a statement of capabilities during the 15 calendar day posting period that meet the requirements set out in the ACAN, the government will proceed to a full tendering process on either the government's electronic tendering service or through traditional means, in order to award the contract.

If no other supplier submits, on or before the closing date, a statement of capabilities meeting the requirements set out in the ACAN, a contract will be awarded to the pre-selected supplier, as referenced above.

BACKGROUND

The Science and Technology Branch (STB) of AAFC recently received funding to undertake a project examining the sustainability of removing corn stover from the fields of corn growers in south western Ontario for use as a feedstock to produce renewable biofuels and biochemicals. Generally, stover is left on the fields as a soil cover against soil erosion.

The proposed work will increase STB's understanding of the sustainability and viability of removing corn stover from farmers' fields for the development of biofuel and biochemical corn stover supply chains in Ontario and Quebec. In particular, this project will determine the delivered cost per tonne of stover, and the potential changes in soil carbon and several other sustainability indicators related to the removal of corn stover from corn fields. This information is of critical importance to farmers who need to understand the economic and environmental impacts of removing the stover from their fields. Using corn stover as a feedstock in the production of biofuels and biochemicals represents a new opportunity for the agricultural sector to diversify and increase its revenues from an existing crop.

CURRENT REQUIREMENTS

The contractor will perform data collection and analysis directly from farmer's fields which represent a unique method of real time data collection versus the traditional method of conducting research on small research plots on AAFC research stations.

DELIVERABLES:

The contractor will conduct the following activities and provide the data and other results to STB:

- Fall and spring soil sampling
- Testing of harvest equipment and subsequent impact on crop and soil quality parameters
- Collection of corn production practices information and sustainability data
- Economic analysis

STB will analyze the soil sampling tests and determine parameters of sustainability.

CONTRACT PERIOD

The resulting contract will be valid from date of award to March 31st, 2015.

QUALIFICATIONS & JUSTIFICATION

To fulfill the requirements of the contract, the person or firm must be able to have easy, unencumbered access to:

- a large number of commercial scale corn fields on which the data collection will occur;
- the farmers of these commercial scale corn fields and
- the farmers crop production and management records.

The Ontario Federation of Agriculture (OFA) is Canada's largest voluntary farm organization representing more than 37,000 farms across Ontario.
