Does this one contract have to be 1 of the 5 contracts used at M1 or can it be a separate contract?”

ANSWER 10:

Answer 2 should have read: “This one contract can be a separate contract.”

QUESTION 11:

For all work streams, in response to R1, the bidder is asked to complete the Response Template - Billable Days (For Criteria M1 and R1) at Attachment 3.2 Page 78. However, this table differs from the sample provided in R1 for Corporate Rated Requirements. Is the bidder to modify the table to suit R1 in order to demonstrate the billable days in excess of the minimum billable days under M1?
