

Financial Bid

Submit the technical proposal (non-cost criteria) **separate from** the financial proposal (2 separate files or envelopes). **Submissions that do NOT separate technical proposals from the financial proposal will be disqualified. Electronic (Email) submissions are preferred.**

Reference number K4E21-13-0401 MUST appear on all submissions.

1. Selection of the contractor(s) will be made on the basis of the best overall value to the Crown in terms of technical merit and cost; the lowest overall priced compliant proposal will be awarded a contract. It is Environment Canada's preference to award one contract.
2. In the event that no one contractor can perform all of the tasks outlined in the above Statement of Work, then multiple contracts may be awarded based on the lowest price per Area.
3. Bidders are to submit a cost proposal that includes a price for each Area, as well as a total overall price (for all areas that they are bidding on)
4. Bidders must include in their cost proposal a detailed breakdown of their fees including estimated travel expenses. Bidders are to ensure that their firm bid price takes into account all labour, equipment, expenses (including travel) that may be associated with this contract.

NUNAVUT LAND CLAIMS AGREEMENT – EVALUATION CRITERIA – POTENTIAL REDUCTION

All proposals received that have met all the mandatory requirements will be evaluated and assigned percentages in accordance with the degree to which the proposals meet the following criteria.

Bidders are requested to demonstrate if and how one or more of the following desirable bid evaluation criteria will be met:

a) Having head offices, administrative offices or other facilities in the Nunavut Settlement Area: YES ___ NO ___	2.5 %
b) Employing Inuit labour, engagement of Inuit professional services or use of suppliers that are Inuit or Inuit Bidders in carrying out the requirement YES ___ NO ___	5 %
c) Undertaking commitments, under the Contract, with respect to on-the-job training or skills development for Inuit. YES ___ NO ___	2.5 %
TOTAL POSSIBLE REDUCTION 10 %	

For evaluation purposes only, the percentage reduction will be deducted from a bidder's evaluated price, for up to a maximum of ten (10) percent. If awarded the contract, the successful bidder will charge its bid price, without the deduction.

Where:

- "Inuit" is as defined in Article 1 of the NLCA; and
- "Inuit firm" as defined in Article 24.1.1 of the NLCA, or a firm listed on the Inuit Firm Registry (www.inuitfirm.com/public/index.html).

In order for the percentage reduction to be applied to the bid evaluation, bidders must provide in their bid, written proof of meeting the bid criteria. Acceptable forms of written proof include, but are not limited to:

- Listing on the Nunavut Tunngavik Incorporated (NTI) Inuit Firm Registry (<http://www.inuitfirm.com/public/index.htm>) or a certificate of Inuit firm status from NTI;
- a letter detailing the names of Inuit employees and the number of Inuit employees;
- a list of the Inuit suppliers to be engaged in carrying out the requirement; and
- the location of head office, administrative office and other facilities.
- a training plan for on-the-job training and skills development for Inuit.
