This Amendment #4 is raised to answer the following question:

Q1: In Annex B, Basis of Payment Section B (page 29) discusses fixed communications fee; major disbursements; and travel and living expenses. However in Section 4 Total Evaluated Price, page 34, the "Total Evaluated Price" table does not provide a line item for travel and living expenses. Should this line item be included in the Total Evaluated Price table?

A1: No, this line item should not be included in the Total Evaluated Price table. Travel costs are not required at this time but will be paid at cost, without any allowance for profit and/or administrative overhead, as per the clause at iii. Travel and Living Expenses at Section 1.
