## **Questions and Answers**

---

- 1) **Question:** Would you accept a mill specification sheet and a certificate of compliance from Doubletex for the pre-award samples?

**Answer:** Yes, CRA will accept a mill specification and a certificate of compliance from Doubletex for the pre-award samples if the fabric proposed is Doubletex. If the fabric proposed is not Doubletex, then independent laboratory test results are required.

- 2) **Question:** Would you be willing to accept our fabrics in a colour other than your custom navy for the pre-award samples?

**Answer:** No, CRA will not accept fabrics in a colour other than those colours specified in the RFP.

- 3) **Question:** We are in need of specific information regarding this bid project. Specifically, clarification or an image depicting the back strap and adjusters for the cap. The information states that there is a male and female snap, but can you clarify what type of snap and what type of slider is specifically required for this cap design.

**Answer:** See amendment 2) below.

- 4) **Question:** Please confirm that the embroidery for all the garments and caps are to be one single color (ie. Canada flag maple leaf and side bars are filled embroidery, and the inside – usually white portion of the flag is empty to be the color of the garment). In addition to confirming that the sizes of the embroidery design to be consistent throughout all sizes?

**Answer:** All of the embroidery (including the maple leaf and the Canada wordmark) is in the **Pantone Colour – Lemon Chrome 13-0859 TP. Yes** - the sizes of the embroidery design must be consistent throughout all sizes.
