3. Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than five (5) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that the Bidder do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all bidders. Enquiries not submitted in a form that can be distributed to all bidders may not be answered by Canada.

4. Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in province of Quebec.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. Statement of Requirement

Title : Diesel fired rubber rised asphalt boiler

1. REACH

1.1. Reach: Furnish a rubber rised asphalt boiler as indicated in this demand. The asphalt boiler has to be on a trailer. The material will be heated by liquid propane. She has to encounter the specifications below and can't be a prototype. This equipment has to do his proofs in other airports for his reliability and working. The equipment has to be brand new.

2. GENERALS REQUIREMENTS

2.1. REQUIREMENTS: In this present specification, words and expressions like «has to, have to be at least, up to, don't rise above» are referring to a requirement. No variance to this requirement will be authorized.

3. STANDARDS

3.1. GENERALITIES: For any reason other than a contrary indication, all the requirements and standards in the present are the most recent one.

3.2. TRAFFIC REGULATION: The boiler has to be conforming to the requirements of the traffic regulations of Quebec.

4. DELIVERY

4.1. SET-UP BEFORE DELIVERY: The set-up has to be done by the contender. This one has to provide, if required, any services after delivery including maintenance, warranty, etc. **The delivery must be made by or before : February, 28 2014 at 1000 Blvd Laure Est , Sept Iles, QC G4R 4K2**

4.2. DOCUMENTS: All documents required by the Vehicle Agency of Quebec (origin certificate, weight certificate, etc.) have to be given to the custodian at delivery.

4.3. INSPECTION: The seller has to be sure that the boiler has been tested, completely inspected and conform to the requirements before delivery. The buyer has the right to inspect the boiler at any step of the production and ask correction for any conformity default. A final inspection must be done by the custodian at the delivery.

5. WARRANTY, MANUALS AND CATALOGS

5.1. MANUALS AND CATALOGS: The boiler has to be delivered with (3) three French copies of the following manuals: maintenance book and pieces catalog. All manuals have to be delivered with the boiler.

5.2. WARRANTY PERIOD: The warranty has to cover the pieces and the labor for at least a period of 24 months beginning to the delivery of the boiler.

5.3. DEMANDS IN ACCORDANCE WITH THE WARRANTY: If the repairs in accordance with the warranty are not beginning into the 48 hours following the demand, the buyer has the right to do the repairs and ask a refund to the manufacturer or the supplier. The refund includes the price of the material and the labor cost calculated in function of the scale of charges and the hourly rate of the airport.

6. ASPHALT BOILER

- 6.1. Supply a rubber lined asphalt boiler conform to the following specifications:
- 6.1.1. The boiler will have to have a minimum capacity of 926 liters with a minimal capacity of heat oil transfer of 132 liters.
 - 6.1.2. A 6HP diesel engine will drive a mechanical agitator.
 - 6.1.3. The heating of the boiler will be done with a 410,000 Btu liquid propane burners that will heat during the working sessions. An automatic control of the sealing material temperature is required to avoid and prevent fire.
 - 6.1.4. The boiler body will be in thick steel covered with epoxy paint for intense service.
 - 6.1.5. A mechanical agitator will allow a uniform mix of the sealing material.
 - 6.1.6. The gravity pouring of the liquid will be dispensed by a distributing valve of 3 pc minimum.
 - 6.1.7. The trailer will be built in U form iron for intense service. All the joints will be sealed. Axles, in pair of two, will be used for intense service and industrial quality. A «pintle eye» coupling ring and security chains will be furnished with the machine.
 - 6.1.8. The trailer will be equipped with required brakes and lights as the road standards.
 - 6.1.9. The trailer will have to be compact and conceived only for the asphalt boiler.
 - 6.1.10. A yellow flashing light will have to be installed at the highest point of the boiler.
 - 6.1.11. An extinguisher for petrol products will have to be installed on the boiler.
 - 6.1.12. The equipment will have to be painted in epoxy «international orange» color in reference. Sico 585-762, Dupont #3216 or other equivalent color.
