**A2:** PLNS is the abbreviation that appears elsewhere in the solicitation and is short form for "Portable Liquid Nitrogen System".

**Q3:** Pg. 1 Cover page states delivery is 2013-07-16. While Pg. 12 stated delivery is March 31, 2014. I assume the delivery on page one is incorrect

**A3:** Correct. The cover page should have stated March 31, 2014, which is the correct delivery date.
