**Amendment 005**

THIS AMENDMENT TO THE SOLICITATION IS RAISED TO PUBLISH SET NO. 3 OF BIDDERS QUESTIONS AND CANADA'S ANSWERS.

**Set No. 3**

Q10: In accordance with SACC Manual clause A3050T Paragraph 2 - Canadian Content Definition, a Canadian Service is defined as:

Canadian service: A service provided by an individual based in Canada is considered a Canadian service. Where a requirement consists of only one service, which is being provided by more than one individual, the service will be considered Canadian if a minimum of 80 percent of the total bid price for the service is provided by individuals based in Canada.

a) Please clarify if this requirement must be met at the time of the RFSA Bid submittal or can it be met once a contract/tasking is awarded under a supply arrangement?

b) It is also requested that Canada clarify of what specifically meets the requirements of "an individual based in Canada"?

A10: a) This requirement must be met upon delivery of services.

b) "Based in Canada" means that the taxes for the work is paid to the Canadian Government in Canada. So whether by visa/work permit or temporary or permanent residency this criteria must be met.

Q11: Please provide clarity as it relates to occupational levels section 6 (Pages 8 and 9 of 10). Specifically, under Technical Specialist Mandatory Requirements it states that if an individual who has a college diploma wants to be considered as a Senior Technical Specialist they must have 20 years of experience. Is this interpretation correct?

A11: Yes this interpretation is correct.

Q12: With regards to ANNEX B "Maximum per diem rates schedule" and Annex D "Financial Evaluation Plan" is it correct to assume that we are only to fill out the tables in ANNEX D and that the supplier will be responsible to fill in the tables in ANNEX B?

A12: Yes, suppliers and resources are to co-ordinate amongst themselves which tables they will respectively prepare for submission. Accuracy between Annex B and Annex D are at the sole risk and discretion of the bidder.
