This solicitation amendment number one (02) is issued to answer questions and comments received during the optional site visit on November 18, 2013, and to provide photos of roof access and a drawing of the building.

Answers to comments/ questions put forward at site meeting on November 18, 2013.

Q1. There were no dimensions on the tender drawings. Will Parks Canada provide a plan with dimensions?

- A. Dimensions were not provided due to the complexity of the plan but can be scaled from the building elevations and roof plan. As per the general notes, sheet A1 of the plans, "Measurements to be confirmed on site prior to construction."

Q2. Where stucco is cut or damaged during removal of flashing, how is the cut or damaged edge to be treated?

- A. The cut or damaged edge is to be sealed with a product compatible with metal and stucco substrates and meeting requirements of Section 07 62 00: Sheet Metal Flashing and Trim – Paragraph 2.3: Accessories and Section 07 92 00: Joint Sealants.

Q3: Is repointing required on the full height of chimney or only from eave up?

- A. Repointing of the chimney is required from the eave up.

Q4. Is the attic above the vaulted VIA concourse area accessible?

- A. Yes, the attic space above the vaulted VIA concourse accessible. Refer to attached drawing and pictures.

Q5. Do roofers require certification to work on structures over 9.5 ft.?

- A. Section 01 35 29.06 Health and Safety Requirements references the Alberta and Federal health and safety codes. Both have requirements for fall protection - the Alberta code applies generally to heights over 3m and the federal one applies generally to heights over 2.4m. From the spec:

"1.8 COMPLIANCE

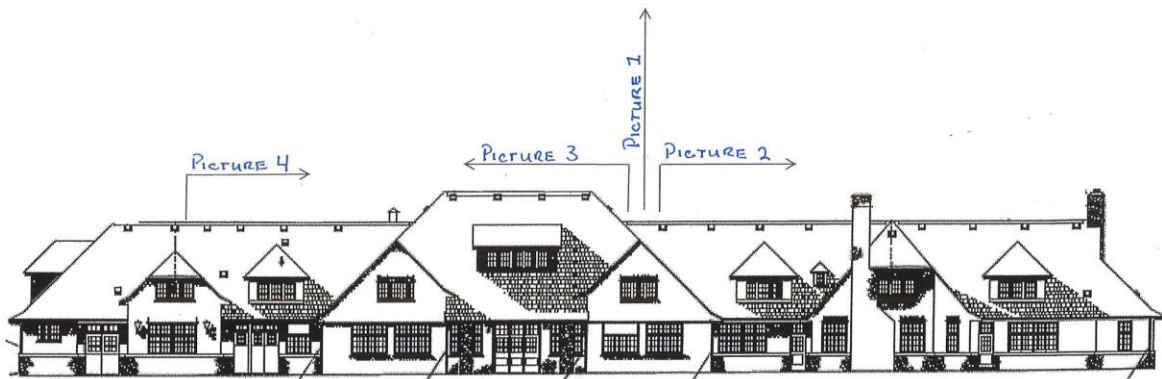
