Question 109

There is no cable tray shown on the drawings other than in the I.T. room. Is there cable tray through the new addition? And if so, sizing and layout should be provided.

Answer 109

There is no cable tray required other than that shown in the IT Room.

Question 110

The existing 800A breaker that is being replaced, is it fixed or draw-out? Is it mechanically or electrically operated?

Answer 110

It is understood that the breaker is fixed and electrically operated. Refer to Addendum 04 – 2013 11 22 for additional detail on switchboard. This is all information available at this time.

Question 111

Addendum number 6 shows the swbd nameplate information with the shop order number Eaton and Wesco files do not go back that far so we do not have the shop drawings for this order. Also show on addendum #6 was nameplate information on the main breaker in the swbd. It indicates that it is a DS416 air circuit breaker. This breaker has a few options that we need to know in order to modify the breaker. The breaker can be fixed mounted were it is directly connected to the bus of the swbd. The other option is that it can be drawn out of the swbd so that maintenance can be performed on the breaker we need to know which version it is.
