This amendment is raised to respond provide answer to questions regarding the subject of Environmental Handling Fees.

All other terms and conditions remain unchanged.

The Government of Canada Pays Environmental Handling Fees (EHFs)

In Canada, both "extended producer responsibility" (EPR) and "product stewardship" programs are used to manage products at the end-of-life.

An EPR program specifically identifies end-of-life management of products as the responsibility of producers (e.g. brand owners, first importers or manufacturers), where a "product stewardship" program generally allocates responsibility to provincial or municipal governments.

The main difference between the two approaches is that funding for EPR programs is provided by producers. Cost can be internalized as a factor of production or may be passed on to consumers.

In this instance, the Government of Canada is asking for the EHF's to be internalized in the price. This means that the EHF's will be paid by the Government of Canada. The only difference with the current approach resides in the fact that the EHF's will no longer be itemized; there will be one price on which applicable taxes will be added.
