Part A: Question and Answers

Q31: Can we provide a T5 fluorescent (High out put 54 watts) vs T8?

A31: Yes.

Q32: Can we provide image processing sensors on every possible aisle? Image processing sensors to cover the entire length of the aisle at 25.4 mm (1") centers.

A32: Yes.

Q33: In reference to the HR and Skills Development tender, G5169-130002/A, is the canopy mounted aisle lighting mandatory to submit a bid? Other sites have installed ceiling mounted lighting with area motions sensors as a cost savings to light fixtures on every carriage.

A33: "Systems must be equipped with system mounted lights"

"Aisle light must provide an average of 300 Lux of illumination for the full length of the aisle."

"Lights must be programmed automatically be activated as soon as carriages movement begins."

"Lights must have the ability to be activated manually in an open aisle and deactivated in an open aisle."

"Lights must have the ability to be activated in an open aisle by aisles entry sensor, sweep or cross aisle sensors."

"Lights must be controlled independent from the base building light circuits."

"Light mounts must be mounted high enough to allow for a person on top of a 1.5m (5'-0") ladder to pass underneath safely."

Q34: Will the doors along the walls in the drawings be opened and require clear space? They were boarded up at the site meeting and we didn't hear if this was answered.

A34: These are just openings. They will not have doors on them. They are currently boarded up to provide security and a division between the existing and new space. The only doors will be from the finished office areas and they will have automatic sliding doors.

Q35: 36" aisles are not suitable for mobile ladders that FMC is currently using. Aisles will need to be bigger. We also need to know how many aisles are on both systems.

A35: Each unit is to have 3x 42" wide aisle ways.
