This amendment 004 is issued to amend solicitation E0209-140961/A as follows:

A: Post answers to the questions received during the solicitation period;

B: Modifications to the Solicitation.

Part A: Questions and Answers

Q4: 1 Touchdown Stations

- When we read the General Requirements for the Touchdown Stations under the headline "Connectors", item 22. The description mentions straight, corner, 3-Way, and 4-Way connectors allowing for all types of panel connection without causing system creep.

- Can you please clarify that with these Touchdown stations you are NOT looking to have panels between Touchdown Stations?

- Is power required from the furniture vendor for the Touchdown Stations?

A4: Our drawings reflect that the power wiring is part of the system furniture.

Q5: 2 Work Wall

- Appendix C asks for adjustable shelves open to both sides. The description of "Open to Both Sides" do you mean that having them open with no doors, or open so they can access the wall for power and data at all heights?

A5: Shelves to be open to both sides with no doors.

Q6: 3 a) For the 8 large tablet arm chairs, can the cup and tablet arm holder be a painted metal metallic finish rather than polished aluminum?

A6: Per NEB response, only polished aluminum for the tablet arm and cup holder are acceptable.

Q7: 4 b) Also, for this item, I would like to ask if it may be acceptable for the depth to be 29.25" rather than 31", and the height to be 31.25" rather than 35"?

A7: Per NEB response, a width of 29.25" is acceptable. A height of 31.25" is also acceptable.

Q8: 5 The product that I would like to respond with has the following specifications, will this be acceptable?

Re #4 Stools...

Seat width requested 17.25 +/- 1.5"

Our proposed product is 19"

A8.1: We would accept.

Seat depth requested 21" +/-1.5"

Our proposed product is 23"

A8.2: We would accept.

Height requested is 44" +/-1.5"

Our proposed product is 41.25"

A8.3: We cannot accept this. The height must be no lower than 44" +/- 1.5".

Q9: 6 Also Stools #6, #7 requests a " with weight assisted recline mechanism" Please confirm that this a mechanical system and not just a flex back?

A9: We suggest a flex back.

Q10: 7 The sofa seating and club seating is asking for fixed cushions in the general requirements. The product we have in mind is not fixed, it is reversible and replaceable. Would this be okay? It would be recommended, as cushions can be replaced in future.

A10: Non-fixed cushions would not accept.

Q11: 8 The working wall unit. It states in one section of RFP calling for laminate finish, then in the general requirements it is asking for wood veneer. Please advise which one is applicable for these working wall units. Wood veneer finish? Or Laminate finish?

A11: We would suggest a laminate finish.
