Atomic Energy of Canada Limited (AECL) requires the services of a contractor to manage the site operating company that will be responsible for the management and operation of AECL's nuclear laboratories under a Government-owned, Contractor-operated model.

In response to feedback provided by Respondents during the one-on-one meetings and in the Request for Information (RFI) responses, required security levels for access to the Request for Response Evaluation (RFRE) data room and for participation in the detailed consultations have been reduced from the levels anticipated during the RFI.

Qualified Respondents seeking access to information during the RFRE will require Designated Organization Screening (DOS) at Reliability (or equivalent), Document Safeguarding at Protected B (or equivalent) Facility Site Clearance at Protected B or equivalent, and Personnel security screening at Reliability (or equivalent).

As well, in an effort to expedite security clearances AECL will take over the responsibility of processing security requests.

Current CISC Certificates of Clearance will be recognized by AECL.
