Amendment 001 is raised to answer the following question:

Question 1: With respect to the tender mentioned above we have a question regarding the amended insurance terms. In section SC01, there is a requirement for Protection & Indemnity (P&I) insurance. Our broker indicates that this insurance is required where watercraft are involved. Our question is , if no watercraft (barges, boats etc.) are to be used and our work crew is covered by workers compensation, is this insurance still a requirement.

Answer to Question 1: The Certificate of Insurance page 1 of 2 of the Invitation to Tender stipulates the type of insurance that is required for this procurement. Only insurance policies check marked in Certificate of Insurance page 1 of 2 of the invitation to Tender are required for this procurement. Marine Liability Insurance, Contractor Pollution Liability and Aviation Liability insurance policies does not apply to this procurement.
