QUESTION 37:**RFP Item 3.3 Section II: Financial Bid, page 14 of 85 of RFP**

It is requested that Bidders use the template provided as Attachment 3.3; it is also stated that the total amount of applicable taxes must be shown separately.

However, Annex B Basis of Payment and the Attachment 3.3 do not provide adequate space for taxes. Is it acceptable to add a column on the right hand side of Attachment 3?

ANSWER 37

The RFP is amended as follows to address this:

At RFP Article 3.3(a):

DELETE: The total amount of applicable taxes must be shown separately, if applicable.

QUESTION 38:**Re: AMENDMENT 001; ANSWER 1**

"The 24 month period has to be the same 24 month period for the 5 contracts."

Would the Crown please consider modifying this requirement to accept a 24 month period within the last 6 years.

ANSWER 38:

Canada has reviewed the request, however the criteria will remain unchanged. Canada does not consider that billable days experience that has occurred more than five years ago is sufficiently recent to ascertain the Bidders ability to provide the resource categories in the estimated anticipated volume under the current requirement.

Note that Answer 13 increased the number of Contract References from 5 to 10.

ALL OTHER TERMS AND CONDITIONS OF THE RFP REMAIN UNCHANGED.
