This solicitation amendment no. 001 is raised to answer questions pertaining to the RFP as well as to revise the RFP, as detailed below:

1. Questions and Answers:

Question 1

Pg 9 (7 of 42), Part 2, Section 1. The solicitation states, "Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation..." To clarify, can the bidder submit exceptions to the solicitation terms and conditions and negotiate on said exceptions?

Response 1

The Bidder cannot submit exceptions to the solicitation terms and conditions and cannot negotiate with Canada. Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation. Please note that it is the Bidder's responsibility to obtain clarification of the requirements contained in the bid solicitation, if necessary, before submitting a bid.

Question 2

Pg 12 (10 of 42), Part 3, Section 1. Under "Section I: Technical Bid", the solicitation states, "*The technical bid should address clearly and in sufficient depth the points that are subject to the evaluation criteria against which the bid will be evaluated.*" To confirm, does this mean that for the Technical Bid, the bidder only needs to respond to the Mandatory Technical Criteria and the Point Rated Technical Criteria in Attachment 1 to Part 4? Or does PWGSC expect the bidder to respond directly to Annex A, Statement of Work and the Appendices in some way? If we are to respond directly to the SOW, how does PWGSC want the bidder to do that?

Response 2

PWGSC do not expect, nor do not object to the bidder responding directly to Annex A, Statement of Work. Please note that Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation, which include the Annex A, Statement of Work, in its entirety. Bids will be assessed in accordance with the entire requirement of the bid solicitation.

Question 3

As mentioned in a previous communication, we, the TD Bank welcome the opportunity to formally respond to Canada's RFP for Card Acceptance Services.

We appreciate that the deadline to respond has been set for January 14th, 2014. However, due to the response time spanning through the Holiday Season, we kindly ask for a minimum two (2) week extension to allow us to properly address the sheer breadth of information included in the document and to formulate an adequate response that will satisfy your requirements.
