SOLICITATION AMENDMENT No. 001

The following is provided as clarification in response to questions received and to provide revision concerning the subject Request for Proposal (RFP).

- Q1** Is there or has there ever been a vendor providing some or all of these services and if so, can the client please identify the vendor and disclose the dollar value associated with the contract?
- A1** *There are resources performing similar services but the resources required under this solicitation are over and above the current resources providing services. Therefore, there is no incumbent Contractor.*
- Q2** In regards to the solicitation, is there currently, or has there been within the past 6 months, incumbents performing similar duties as described in the Statement of Work?
- A2** *See A1.*
- Q3** Previous Requests for Proposals have shown that these skill sets are rare and previous Canada Border Services Agency (CBSA) requirements like this have been changed to accept with Reliability Status resources as recently as a year ago. Given that CBSA will conduct its own clearance of resources, the contract duration is for multiple years (potentially) and CBSA is intending to award up to five contracts, would CBSA accept a proposal that includes resources with Reliability Status?
- A3** *No. The resources that will work on CBSA's projects will have access to artifacts that are in the range of Protected B to Secret.*
- Q4** Could you clarify the scoring for the rated criteria PA1-R.1 and PA2-R.1? In PA1-R.1 and PA2-R.1 there is 1 protocol and 4 languages listed so it is therefore impossible to have experience in more than one protocol.
- A4** *See attached revised Attachment 4.1 - Bid Evaluation Criteria.*

Q5 Section 4.4 (d) states the possibility of awarding up to five contracts. To clarify, does that mean that vendors are not obligated to present all five resources in their proposal and are permitted to may present any combination of resources up to and including the maximum indicated in section 1.2 (g) for each category?

A5 *Bidders can propose any combination of resources up to and including the maximum indicated in section 1.2 (g) for each category, but the same resource cannot be proposed for more than one category.*

Q6 Being that there can be up to 5 contracts awarded and these skill sets are often quite difficult to find, could the Crown please clarify if a company's bid submission needs to include 5 resources (2 Platform Analysts – with SBI experience and 3 Platform Analysts – with EDI experience) or are we able to submit any number of resources for each category?
