An advanced contract award notice (ACAN) is a public notice indicating to the supplier community that a department or agency intends to award a contract for goods, services or construction to a pre-identified supplier, thereby allowing other suppliers to signal their interest in bidding, by submitting a statement of capabilities. If no supplier submits a statement of capabilities that meet the requirements set out in the ACAN, on or before the closing date and time stated in the ACAN, the contracting officer may then proceed with the award to the pre-identified supplier.

# 1. Definition of requirement:

The Correctional Service Canada has a requirement to provide routine and emergency psychiatric services to Grand Valley Institution for Women's inmate population. The work will involve the following:

1.1 Objectives:

To provide consultation, assessment and treatment of emergency psychiatric referrals, to provide the administration and monitoring of psychotropic medications, and to provide individual case consultation to the institutional mental health team.

1.2 Tasks:

The Contractor must complete each individual consultation, assessment and treatment progress summary/ doctors' orders form in the offender's Health care file.

The Contractor will liaise with Institutional Health Care, Mental Health Team, Case Management and Correctional Programs with regard to Correctional Service Canada policy on disclosure of offender medical information.

The Contractor will advise the Chief of Health Services as to case disposition.

The Contractor will adhere to the approved formulary when prescribing medication. Additions, deletions and Substitutions shall be determined by the Pharmacy and Therapeutic Committee.

1.3 Expected results:

To prescribe and administer treatment as indicated.

To provide emergency mental health services beyond the weekly session(s) in the case of client/offender exhibiting signs and symptoms of major mental disturbance/crisis intervention when deemed necessary, on an emergency basis only.

To provide scheduled sessions which may include evenings, in which referred clients/offenders would be assessed/evaluated and/or treated in accordance with the principles governing the management and delivery of health services by the Correctional Service Canada and conforming to professionally accepted standards.

To be an active member of the multidisciplinary team through positive interaction with institutional staff at all levels.

1.4 Performance standards:

To complete 3 hour weekly clinics at Grand Valley Institution to a maximum 48 weeks per year. Including ad-hoc meetings with the institutional mental health team.

To provide emergency call-back services as needed for individual cases.

- 1.5 Deliverables:
- 1.5.1 To provide and submit written documentation to the medical file and psychiatric files on the assessments/evaluations and/or treatments of individual clients/offenders and to the Chief Health Services no later than five working days following the interview.

To be an active member of the multidisciplinary team through positive interaction with institutional staff at all levels.

- 1.5.2 Paper consumption:
  - a. Should printed material be required, double sided printing in black and white format is the default unless otherwise specified by the Project Authority.
  - b. The Contractor must ensure printed material is on paper with a minimum recycled content of 30% and/or certified as originating from a sustainably managed forest.
  - c. The Contractor must recycle unneeded printed documents (in accordance with Security Requirements).
- 1.6 Constraints:

1.6.2 Language of Work:

The contractor must perform all work in English

1.6.3 Security Requirements:

This contract includes the following security requirements:

- a. The Contractor must, at all times during the performance of the Contract, hold a valid Designated Organization Screening (DOS), issued by the Canadian Industrial Security Directorate (CISD), Public Works and Government Services Canada (PWGSC).
- b. The Contractor personnel requiring access to sensitive work site(s) must EACH hold a valid reliability status, granted or approved by CISD/PWGSC.
- c. Subcontracts which contain security requirements are NOT to be awarded without the prior written permission of CISD/PWGSC.

### Experience:

Completion of a minimum of five years of additional accredited training following four years of general medicine training.

### Professional designation, accreditation and/or certification:

Licensed psychiatrist
