This amendment is raised to make the following clarifications:

In the "SUBMISSION REQUIREMENT AND EVALUATION (SRE), Section SRE 3, Items 3.2.4 *Senior Personnel Expertise and Experience* and 3.2.5 *Project Personnel Expertise and Experience*, two (2) cv's in total for each of these sections, not two (2) per practice area. The proponent will need to make the decision on what specialties to submit for each section, and, based on the information provided in the RFSO, what to include in their entire submission.

The RCMP Project Manager/Departmental Representative will determine what specific specialties are required to complete each individual project, at the time the project is initiated and sent to the consultant for quotation. Different projects will require different specialties and additional information on personnel may be requested before a specific project is awarded via Call-up (ie. the proponent requires a sub-consultant to complete a requested project).
