**This Solicitation Amendment no. 002 is raised to amend the Request for Proposal as follows:**

**1. At Article 1.2 Summary:**

**DELETE** Paragraph (e) in its entirety.

**INSERT:**

- (e) Only TBIPS SA Holders currently holding a TBIPS SA for Tier 2 in the National Capital Region under the EN578-055605/D series of SAs are eligible to compete. The TBIPS SA EN578-055605/D is incorporated by reference and forms part of this bid solicitation, as though expressly set out in it, subject to any express terms and conditions contained in this bid solicitation. The capitalized terms not defined in this bid solicitation have the meaning given to them in the TBIPS SA.

**2. At Article 1.2 Summary:**

**DELETE** Paragraph (f) in its entirety.

**INSERT:**

- (f) SA Holders that are invited to compete as a joint venture must submit a bid as that joint venture SA Holder, forming no other joint venture to bid. Any joint venture must be already qualified under the SA #EN578-055605/D as that joint venture at the time of bid closing in order to submit a bid.
