1. REMINDER:

Submission of Bids

Bids must be submitted **ONLY TO PUBLIC WORKS AND GOVERNMENT SERVICES CANADA (PWGSC) BID RECEIVING UNIT** by the date, time and place indicated on page 1 of the bid solicitation.

- a) Two (2) hard copies of the Contractor's proposal must be mailed to the Bid Receiving Unit, as per page 1 of the bid solicitation;
- b) One (1) electronic copy of the Contractor's proposal must be mailed to the Bid Receiving Unit, as per page 1 of the bid solicitation on a standard USB key with the two (2) hard copies. The Annexes must be in Excel format.

Note to Bidders: Faxed copies of any Contractor's proposal **will not be accepted** for the two (2) requested hard copies. Should the prices in the electronic copy deviate from the hard copies, the prices in the hard copies take precedence. The Contracting Authority retains the right to clarify any questions regarding a submitted proposal.
