**This amendment is issued to Solicitation W0127-13P010/A to answer the following questions and make the following changes:**

**Question 1** - Will up to a 750cc 30 HP EFI be acceptable for Canada?

**Answer** - Yes

**Question 2** - What is Canada referring to when you state capable of transporting ATV's? Is Canada referring to the description of ATV as noted in the contract? (ie 8 Wheeled Drive units )

**Answer** - Trailers to haul ATV's should be 14' to 18' in order to haul ATV's that are 4 or 6 Wheeled.

**Question 3** - An 8 Wheeled Drive machine averages 10 feet long. A trailer suitable to transport 2 of these units would be 20 feet long, 4 units - 40 feet long and 6 units - 60 feet long. The 8 Wheeled Drive machines are too wide to transport side by side so all units would need to be loaded end to end.

**Answer** - Offeror does not need to provide trailer transportation for 8 Wheeled. This will be done by Military personnel

**Question 4** - It is also requested that these trailers be towable by truck or an ATV. A trailer suitable to transport two of these units would be towable by a truck but not by an ATV. A trailer suitable to transport 4 or 6 - 8 Wheeled Drive units , would need to be towed by a transport truck.

If Canada is requesting trailers that would be capable of towing a typical ATV - 4X4, then a trailer able to transport 6 ATV's would only need to be 20 - 22 feet long. This type of trailer would be transportable by a pick-up but still not by an ATV.

**Answer** - Request that these trailers be towable by truck or an ATV should read towable by truck only. For trailer to be 20-22 this would be towable by truck only

**Question 5** - Please clarify what trailers are acceptable, what they must be capable of transporting and what kind of equipment will be towing them

**Answer** - Trailers that are acceptable will be in the size from 14-18 ft and will be towed by 4x4 with towable package.

## PART 1 - GENERAL INFORMATION

### 1. Introduction

The Request for Standing Offers (RFSO) is divided into seven parts plus attachments and annexes, as follows:

- Part 1 General Information: provides a general description of the requirement;
- Part 2 Offeror Instructions: provides the instructions applicable to the clauses and conditions of the RFSO;
- Part 3 Offer Preparation Instructions: provides offerors with instructions on how to prepare their offer to address the evaluation criteria specified;
- Part 4 Evaluation Procedures and Basis of Selection: indicates how the evaluation will be conducted, the evaluation criteria which must be addressed in the offer, and the basis of selection;
- Part 5 Certifications: includes the certifications to be provided and
- Part 6 6A, Standing Offer, and 6B, Resulting Contract Clauses:
  - 6A, includes the Standing Offer containing the offer from the Offeror and the applicable clauses and conditions;
  - 6B, includes the clauses and conditions which will apply to any contract resulting from a call-up made pursuant to the Standing Offer.

### 2. Summary

Regional Individual Standing Offer (RISO) for the rental of 4, 6 and 8 Wheeled Drive ATVs & Gator Style Mules, without operators, ATV Trailers and other related equipment to supplement the DND fleet as required by the Department of National Defence Suffield, Wainwright and Edmonton, located in Medicine Hat, Alberta, Denwood, Alberta, and Edmonton, Alberta in accordance with the terms and conditions stated herein. The period for making call-ups against the Standing Offer will be from date of award of the Standing Offer to December 31, 2014 with two (2) one year option years.

Offerors must submit a list of names, or other related information as needed, pursuant to section 01 of Standard Instructions 2006 and 2007.

For services requirements, Offerors in receipt of a pension or a lump sum payment must provide the required information as detailed in article 3 of Part 2 of the Request for Standing Offers (RFSO).

The requirement is subject to the provisions of the World Trade Organization Agreement on Government Procurement (WTO-AGP), the North American Free Trade Agreement (NAFTA), and the Agreement on Internal Trade (AIT).

### 3. Debriefings

Offerors may request a debriefing on the results of the request for standing offers process. Offerors should make the request to the Standing Offer Authority within 15 working days of receipt of the results of the request for standing offers process. The debriefing may be in writing, by telephone or in person.

## PART 2 - OFFEROR INSTRUCTIONS

### 2. Submission of Offers

Offers must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the Request for Standing Offers.

### 3. Enquiries - Request for Standing Offers

All enquiries must be submitted in writing to the Standing Offer Authority no later than fifteen (15) calendar days before the Request for Standing Offers (RFSO) closing date. Enquiries received after that time may not be answered.

Offerors should reference as accurately as possible the numbered item of the RFSO to which the enquiry relates. Care should be taken by offerors to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the questions or may request that offerors do so, so that the proprietary nature of the question is eliminated, and the enquiry can be answered with copies to all offerors. Enquiries not submitted in a form that can be distributed to all offerors may not be answered by Canada.

### 4. Applicable Laws

The Standing Offer and any contract resulting from the Standing Offer must be interpreted and governed, and the relations between the parties determined, by the laws in force in Saskatchewan.

Offerors may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their offer, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the offerors.

## PART 3 - OFFER PREPARATION INSTRUCTIONS

### 1. Offer Preparation Instructions

Canada requests that offerors follow the format instructions described below in the preparation of their offer.

## PART 5 - CERTIFICATIONS

Offerors must provide the required certifications and documentation to be issued a standing offer.

The certifications provided by offerors to Canada are subject to verification by Canada at all times. Canada will declare an offer non-responsive, will have the right to set-aside a standing offer, or will declare a contractor in default, if any certification is found to be untrue whether during the offer evaluation period, during the Standing Offer period, or during the contract period.

The Standing Offer Authority will have the right to ask for additional information to verify the Offeror's certifications. Failure to comply with this request will also render the Offer non-responsive or may result in the setting aside of the Standing Offer or will constitute a default under the Contract.
