This addendum varies the Contract Documents and will form part of the Contract Documents and is to be read, interpreted and coordinated with all other parts, including General and Supplementary General Conditions of the Contract and all Sections in Division 1. The cost of all work contained herein is to be included in the Contract Sum. The following revisions supersede the information contained in the original drawings and specifications issued for the above named project to the extent referenced and shall become a part thereof.

## **1 GENERAL**

- .1 This addendum is issued prior to receipt of Bids to provide for certain revisions to and clarification to the Contract Documents.
- .2 The work required by this Addendum shall be executed in accordance with the requirements of the Contract and Contract Documents.
- .3 Include in the Stipulated Price, the cost of all work described in this Addendum.

## **2 QUERIES**

- .1 Question 1: Can hours of work be extended to accommodate a 12 hours a day?

Response: Yes, but work must be performed only between 0700 to 1900 including weekends and holidays.

During working hours PARC Security will “dis-arm” the building alarm system and then “re-arm” the system at the end of the shift. During weekends and holidays, building security system remains “armed” all day.

To coordinate with the security, hours of work for any given week must be established by Thursday of the preceding week so that PARC Summerland can schedule accordingly and that once those hours have been established for the upcoming week, they will not be allowed to be changed.

- .2 Question 2: Section 015600 states that all AHU filters need to be replaced at the end of construction. If this is the case, can you provide quantity and type of filters to be replaced?

Response: Delete clause “1.6 Additional Filtration” from section 015600.

- .3 Question 3: Once project has been awarded, I have been informed clearance can take up to 3 months. Who pays for the commissionaires in the interim?

Response: There is no requirement for Commissionaires. Contract will not be awarded until security clearance has been completed.
